

COVID SAFE PLAN UPDATED 2nd March 2022

VERY CAREFUL ATTENTION TO THE SIX PRINCIPLES:

- 1. Ensure Physical distancing of minimum 1.5 metres.
- 2. Staff members to wear a Face Mask at all times, Patrons not required.
- 3. Practise Good Hygiene (staff and the encouragement of patrons to do the same)
- 4. Keep Records (using our QR code) and ACT QUICKLY if staff are unwell.
- 5. Avoid interactions in enclosed spaces (and where possible enhance airflow)
- 6. Create workspace bubbles (where possible have same staff working together)

Each staff member to temp check before EVERY shift

COVID Officer(s) to ensure all patrons QR Register and abide by principles above in BOTH Bistro AND Racing Club venues.

Double Vaccination is required to be sighted by the COVID Officer, otherwise patrons will be refused entry.

Electronic gaming – Temlee Sports Lounge:

- Density quotient of 1 person per 2sqm applies.
- COVID Check-in Marshals must ensure attendees check-in.

Hospitality: Graze Family Bistro

- Density quotient of 1 person per 2sqm applies, for seated service.
- Unlimited Outdoors
- COVID Check-in Marshals must ensure attendees check-in.
- Dancefloors closed.
- Encourage six principles (as above) to all patrons and make regular announcements through Club PA System.
- Double Vaccination is required to be sighted by the COVID Officer, otherwise patrons will be refused entry.

Kennelling Process

Security – Media – GRV Steward – Club Manager (as needed)

Security - ensure all participants carry proof of vaccination and after doing so are wrist banded.

Anyone participating in greyhound racing in Victoria, or who undertakes greyhound racing related work *away from home*, from 15 October 2021 must comply with the State Government's **Mandatory Vaccination (Workers) Directions**, unless they hold a valid medical exemption.

The vaccination requirements in these Directions apply to GRV and Club employees, registered owners, breeders, catchers, attendants, owner-trainers and public trainers participating in greyhound racing in various ways. If you fall into any one of these categories and need to leave home to participate or work, the Directions will apply to you.

Examples of a work premises *away from home* include, but are not limited to, Club training or racing facilities, or another participant's private trialling facilities, such as a bullring, or exercise yards.

Greyhound racing related work includes any activities related to, or which support greyhound breeding, training and/or racing that is conducted, or performed for you, or for someone else away from your home. This work may be paid, or unpaid.

Participants can enter SGC venue IF previously wrist banded at Kennels.

COVID Positive Employees or Patrons:
